Initially member secretary sanctioned the amount of Rs. 20000/-as seed/token money against printing and postage charges for the said conference to the convener. Out of Rs 20,000/- a sum of Rs 3025/- was deposited by the conference conveyer and Rs 16975/- was due.

The total income from sponsorship, registration fee and others was Rs. 6,90,900 and total expenditure was Rs. 7,07,875/- in various heads. The excess expenditure was Rs. 16,975/- .
