Item No. 10.5: To approve and provide financial block grant in salary head through finance department.

Engineering College Bikaner is an autonomous institution of Govt. of Rajasthan and as per the govt. directions, it has acted as facilitating institute from time to time to start new

technical institution such as College of Engineering and Technology Bikaner, Engineering

College Bharatpur, Center for E Governance Jaipur, and Engineering College Barmer and has provided initial corpus fund and financial grant to theses colleges/institutions. Also, over

the time Engineering and Technical institutions are going through deep financial crises; as a

Minutes of Meeting of 10th BoG of ECB Society held on 13th September, 2019 result the institute is not able to pay salary and also find it hard to manage day to day financial needs. So, Technical Education department requested to process the proposal for financial assistance to provide block grant equivalent to salary head difference.

Resolution: The agenda item was deferred.

Agenda Items Related to TEQIP-III of Engineering College Bikaner

Item No. 10.6: Permission is required to conduct the academic activities in the coming months which were scheduled in the month of July, August and September 2019.

Description : In the month of July and August, most the faculty members was busy in NBA related preparations and assignments (visit is scheduled on September 20-22, 2019). So, these academic activities could not be organized which were scheduled in the month of July, August and September. Now permission is required to conduct the same in the coming months.

Resolution: The agenda item was approved as proposed.

Item No. 10.7: To approve the registration and certification fee reimbursement of online digital courses other than NPTEL and SWAYAM platforms; like Coursera, Edx, Udemy, Udacity and Software, under MOOCs and digital learning of TEQIP-III.

Description: Other than SWAYAM and NPTEL there are many other reputed and well recognized digital learning online platform like Coursera, Edx, Udemy, Udacity and other similar platforms which have many useful advanced courses for students and faculty. Reimbursement of registration fee can be provided to faculty as well as students under MOOCS and digital learning of TEQIP-III. It will be very useful for faculty for knowledge enhancement and for students it will be beneficial for industry readiness and employability.

Resolution: The agenda item was approved only for Govt. agencies certification fee.

Item No. 10.8: To approve the reimbursement of the remaining semester Ph. D. / M. Tech. program fees and other minor expense like thesis printing and etc. (permissible under TEQIP-III guidelines) of two regular faculty members Mr. Mohd. Yunus Sheikh (Mechanical Engineering) and Mr. Rajkumar Choudhary (Information Technology).

Description: - BOG has already approved the same agenda in the 7 BOG meeting held on 10/6/2019 (Agenda 7.13, Annexure 5) but the name of these two faculty members were missed in the

list attached at that time. So program fees and other expenses can be reimbursed to above mentioned regular faculty members under the qualification up gradation under TEQIP-III guidelines.

Resolution: The agenda item was approved as proposed.

Item No. 10.9: To approve reimbursement of Ph.D. fee of TEQIP – III (NPIU) faculties who have registered in different NITs under qualification up gradation program of TEQIP – III and similar has been approved in Engineering College Ajmer BOG (agenda no. 12.15) (Annexure 6).

Description: - NPIU has allowed the TEQIP-III faculties to take Ph.D. admission in the NITs. NPIU has also directed institute to reimburse the Ph.D. Semester Fee of TEQIP – III faculties under qualification up gradation program of TEQIP – III. The same has been approve by the Engineering college Ajmer (Letter of the NPIU is attached as annexure 7).

Item No. 10.11: Approval is required to conduct two week FDP on "Advances in Renewable Energy System" by Mechanical Engineering/Chemistry/E&C/EE Department in December 2019.

Description: - The course intended to discuss the recent advances on the renewable energy technologies and systems including the basic working principle. The major topic covers in this programme are (i) Technology-enhanced learning environments (ii) Renewable energy technologies (iii) Energy Resource Mapping (iv) Solar Photovoltaic and Thermal Energy (v) Biomass Energy (vi) Wind Energy (vii) Grid connected renewable energy system (viii) Simulation tools etc. The course will also cover the laboratory components of these energy systems and field visit. Experts from the different reputed academic institutes, research laboratories and industries will be invited to deliver the various aspects of the programme. Apart from the invited



Minutes of Meeting of 10th BoG of ECB Society held on 13th September, 2019 experts, faculties of ECB Bikaner having expertise in the different areas related to the programme will also deliver lectures and approximate cost to organize this FDP will be Rs. 5.0 Lacs (Maximum participants of 80).

Resolution: The agenda item was approved as proposed but detail of expenditure incurred shall be put up in next BoG.

Item No. 10.12:- Approval is required to organize a short term of one week training program (STTP) on "Solar PV Installation" by mechanical department in October/Nov. 2019.

Description: This training program is intended to provide the basic insight of Indian and world energy scenario and basics of solar energy along with various series and parallel combination of modules with hand on practices. The load calculation, design practices and solar battery testing will be done. The training program will also provide the steps of solar power commissioning. The approximate expenditure for organizing this STTP by limited the number of registration up to 80 is Rs. 4.00 Lacs. The tentative date of the STTP will be 1st week of October/Nov. 2019.

Resolution: The agenda item was approved as proposed details of expenditure incurred shall be put up in next BoG.

Item No. 10.13:- Approval is required to organize two week faculty development program (FDP) on "Application of Internet of Things (IoT) in Science & Technology" jointly by IT, CSE and ECE department in October/November 2019.

Description: This faculty development program is intended to provide the basic understanding, recent trends and application in the field of Internet of Things (IoT) in Science & Technology, which is relevant to all the faculty members of the institute. Practical sessions/hands on practice will be also provided to participants. Experts from the various reputed academic institutes and industries will be invited to deliver the various aspects of the programme. The approximate expenditure for organizing this FDP is Rs. 5.00 Lacs. The tentative date of the FDP will be 2nd – 3rd week of October/November 2019 and registration is limited to 65 numbers of participants.
